- Curriculum Vitae - including significant achievements or awards.
- Sample of work: visual artists -12 slides or 12 prints and/or catalogue excerpts; multi-media artists - CD-ROM in PC format or list of URL's or audio cassette tape or audio CD or VHS tape in PAL format, tapes must be cued and the sample selected should be no longer than 10 minutes; composers - one tape, cued and one score; writers - one short story or 3 poems or 3 chapters; scholars - one research paper.
- Two or three reviews of past work.
- A list of the facilities the applicant intends to use at the Sanskriti Kendra.
